This is in response to your Freedom of Information Act request, received in this office on July 22, 2022 requesting the following:

1. Any reports, reviews, assessments, and/or plans for exercises or activities prepared, conducted, or to be conducted pursuant to Section 527 of Public Law 117–81, “National Defense Authorization Act for Fiscal Year 2022”, including any internal SSS reports and any reports, reviews, or assessments communicated by the SSS to the Department of Defense.

2. Any reports prepared pursuant to Section 529(a) of Public Law 117–81, “National Defense Authorization Act for Fiscal Year 2022”.

No record. This board has not meet in over a year as members have changed or departed the Agency. This board has not produced any internal or external reports.

The only existing data matching agreement has been with the Department of Education. This agreement expired on 2 July 2022. Due to change in law, this agreement was not renewed.
